**RELEASE  
AND INDEMNITY AGREEMENT**

I \_\_\_\_\_, knowingly and voluntarily enter into this **RELEASE AND INDEMNITY AGREEMENT**. I acknowledge that I am at least eighteen (18) years of age, or the parent or legal Guardian of the person under the age of eighteen (18) years, and that I and/or the person participating in this event is of sound mind, and know and understand the meaning and effect of this legal document.

It is my express desire to participate in shooting sports at the various facilities of Southern Indiana Rifle and Pistol Club (SIRPC) and at the various events hosted and/or sponsored by SIRPC. This includes participation in sponsored/hosted competitive shooting matches, training events, and at other events sponsored or hosted by SIRPC.

I understand that all shooting sports pose certain inherent dangers and involve risks of injury, death, and/or damage to my property. I hereby assume the risk of injury, death, and/or property damage, caused by or resulting from my participation in any shooting sports event sponsored/hosted by SIRPC.

I hereby RELEASE from any and all liability, SIRPC, its officers, managers, directors, and any other person associated with managing the event in which I may be injured or suffer any damage. This includes but is not limited to range officers, pit bosses, safety officers, training officers, volunteers, or other persons who in any way may be involved in organizing or managing any shooting event sponsored or hosted by SIRPC. I assume full and individual responsibility for any and all injury, death, or property damage that I may suffer while participating in any shooting event. It is my intent for this Release to be construed as broadly as possible and to RELEASE SIRPC, its officers, agents, or any other persons affiliated with the specific shooting sports event in which I may be injured or sustain property damage. I understand that by signing this document I am RELEASING from any and all liability, all persons and entities that may in any way have any responsibility for injuries, damages, or death incurred by me by my participation in any shooting sports event.

I further agree that I shall not sue, present any claim against, attach property, or any way make any claim against any person or entity Released regardless of whether my injury or death was caused by their negligence or from any other cause.

I further agree to INDEMNIFY and hold harmless all of the aforesaid persons or entities Released, for any and all claims made against them by anyone or anything by reason of my participation in any shooting sports event for any injury to my person, my property, or death, caused by or resulting from my participation in this event, whether or not such injury, damage, or death was caused by their negligence. I further agree that I shall protect and/or defend, any person or entity Released from and against any and all demands, claims, suits, damages, judgment, interest, liability, court cost, expenses, including attorneys fees, incurred to defend said claims and/or to uphold this **RELEASE AND INDEMNITY AGREEMENT**.

I understand that this is a CONTRACT and it shall be binding upon me, my heirs, my estate, my assigns, legal guardians and my personal representatives. I have carefully read this **RELEASE AND INDEMNITY AGREEMENT**. I fully understand its meaning and effect. I am aware that I am Releasing certain obligations, entitlements and rights, and that I am binding myself contractually to certain obligations. I enter into this CONTRACT knowingly and of my own free will.
