Monthly Business Meeting Minutes and Newsletter

President Don Copple Sr. welcomed all those in attendance. He called the monthly business meeting of the Southern Indiana Rifle & Pistol Club to order at 7:00 PM on July 7, 2021 at the Indian Creek Shooting Center in Georgetown, IN.

ATTENTION: We have discovered a problem on our website www.sirapc.com. When you open the website, either from your desktop or phone, and click on the tab "calendar", the first page to show is a listing of upcoming events. The problem is that the event scheduled for the day on which you open the calendar, disappears from the abovementioned listing at some point in time before the event is finished. The real life example is that on June 26 around 1:45 PM a member showed up at the Outdoor Range to plink while the 2700 Pistol Match scheduled for that day was still ongoing. At 1:45 PM the Pistol Match was no longer shown on the list of upcoming events for June 26 and the member stated that he checked approximately 45 minutes earlier, before leaving his house, and the match was not shown either. We are working to get this changed. For now please select the calendar view shown as the whole month and ignore the listing of upcoming events. The monthly view continues to show the event regardless of the time of day.
