MINUTES: President Don Copple Sr. asked if there were any questions or comments pertaining to the minutes of the August 4, 2021 meeting. There were no comments and/or revisions. President Copple declared the minutes approved as is.

TREASURER'S REPORT: Tom Clark presented the income and expenses for the month of August. The balance in the operating account on July 31 was \$41,401. The balance on August 31 is \$39,862.

OLD BUSINESS: Don Copple stated that mowing at the Outdoor Range is now at once every 2 weeks due to the dryer weather. NEW BUSINESS: . George Eberhardt made a request for the club to initiate an annual memorial match in Memory of the late Wayne Mcleod who had dedicated significant time and effort to the growth of the club and was very involved with youth shooting sports. The proceeds from this match would be split evenly as donations to the SIRAPC youth program and the Oldham County 4-H youth shooting program that Wayne was very active with. Donnie Abbott reported on the continued growth and success of the electronic targets for the rifle program. He asked the club to make an additional purchase of two electronic targets to make a total of 10 club owned targets for each firing point. Currently the club owns 8 targets and uses two individually owned electronic targets to use all 10 firing points for matches with large turnouts. Donnie also proposed maintenance and improvements to the berms at 200, 300, 500 yards. The expense to the club would be minimal. The work would take place in October. It was also requested that anyone who moves the concrete benches on the pistol range to replace them back when finished. John LeMay wants to investigate if it would be possible for the pistol range to have a fan to be used by competitors on the firing line during matches.
