ATTENTION: The padlock and combination at the outdoor range has been changed to the 2022 combination displayed on your membership card. The lock combination needs to be oriented on the black lines on the upper section of the number wheel and not the middle section like the previous lock. Please check the website for an image of the combination lock and the number orientation.

MINUTES: President Don Copple Sr. asked if there were any questions or comments pertaining to the minutes of the April, 2022 meeting. There were no comments and/or revisions. President Copple declared the minutes approved as is.

TREASURER'S REPORT: Ending Balance in January was \$28,403.00. February income was \$6,347, expenses were \$4,102.00 leaving a balance of \$30,647.00. March expenses were \$604.00 leaving a balance of \$30,043.00. April expense was \$1,114.00 leaving a balance of \$28,929.00. May income was \$6,847.00, expenses were \$1,283.00 leaving a balance of \$34,493.00

OLD BUSINESS: Paul Schindler began mowing the outdoor range this season. The mowing is scheduled for Tuesday afternoons. Please make sure that all target materials are picked up after shooting is completed so that there are no debris left that could damage the mower. President Copple announced that he further researched the issue of the club's property tax liability. He learned that since the club is a non-profit organization that it is exempt from taxes. As a result, he will be submitting the club's Articles of Incorporation to the county to secure the tax exemption.

NEW BUSINESS: Please pick up all your trash such as cleaning patches and swabs as well as large spent brass cases and shotgun shells to try to keep the range as clean as possible for all members. Vice President Donnie Abbott and Drew Rudd gave a brief review of the previous weeks CMP M1/mixed military and vintage sniper matches as well as a brief description of the club's electronic target system. These Targets allow matches to progress much more quickly than a traditional match requiring shooters to have pit duty when they are not shooting. President Copple announced that the club will be displaying at the Columbus gun show.
