The Assessor's board concluded that the club is a nonprofit organization and is exempt from property tax. This exemption must be applied for every two years. The club propane tank at the indoor range has been filled in preparation for cold weather.

**NEW BUSINESS:** Tom Graves requested that the HVAC system be checked to ensure that it is working properly. President Copple agreed and indicated that he would have the system checked on prior to the onset of cold weather.
