**MINUTES:** President Don Copple Sr. asked if there were any questions or comments pertaining to the minutes of the August 2022 meeting. There were no comments and/or revisions. President Copple declared the minutes approved as is.

**OLD BUSINESS:** George Eberhardt reported that we had a successful workday at the outdoor range and that the club would attempt to make these work days a more regular event to provide up keep on the outdoor range. President Copple reported that the furnace at the indoor range has been inspected and is in good working order. The problem with heating the indoor range is due to the large surface area of the concrete that needs to be heated during the winter since the building is only heated during use.

**NEW BUSINESS:** Paul Jackson made a motion to have the door repaired on the indoor range. The motion was seconded and approved. The work will be completed by club members. President Copple reminded members that during a match, the match director or their designee is the sole authority presiding over the course of the match. If a participant has an issue that cannot be resolved in an agreeable manner, then that issue needs to be brought to the attention of the board and discussed outside of the match. Vice-President Abbot congratulated club members, Paul Jackson and Mike Korff on their First-place win in the Vintage Sniper Match at the National Matches at Camp Perry this year. He also mentioned how well the rifle programs have progressed since we implemented the use of the Shotmarker electronic target system. Executive Officer Davis recommended that the club create a plaque to keep up with the club's achievements at the national level as well as the international level of competition. The board was in agreement and future work will attempt to achieve that goal. President Copple raised a question regarding the potential closing of Floyd County Conservation Club. No one in attendance had any knowledge of the closing to determine the accuracy of the statement. Drew Rudd announced that the club would restart a CMP sanctioned rimfire sporter match at the indoor club. The dates and times of these matches will be announced later.
