BY - LAWS

ARTICLE I

OATH OF ALLEGIANCE

I pledge allegiance to the flag of the United States of America and to the Republic for which it stands. I certify that I am a citizen of the United States and that I am not a member of any organization or group pledged to the destruction of our present system of government established by the Constitution of the United States.

ARTICLE II

GUESTS

1. All members are encouraged to teach safe firearms handling and marksmanship skills to family members and guests. If guests desire to attend the Club's facilities on a regular basis, they are encouraged to support the Club by joining in membership.
2. It is prohibited to extend membership privileges to non-members. Members will be given preference on the firing line.
3. A paid entry by a non-member for any open match, sponsored by this Club will guarantee a spot in the match.

ARTICLE III

COMPETITION RULES AND REGULATIONS

1. All sanctioned rifle and pistol competitions held by the Club will be governed by the then current rules and regulations of the National Rifle Association, or other National or International organizations approved by the Club.
2. Responsibility of the Executive Officer will be to make full reports to the Executive Committee, schedule matches, oversee the running of the matches, and to keep accurate account of all moneys collected at the matches.

ARTICLE IV

INITIATION FEES AND DUES

At the annual meeting on January 13th, 2024, the membership voted to delete the Senior and Senior Family membership options starting with calendar year 2025.

1. Dues will be reduced by 1/2 after June 30 for new members. Initiation fee will not be charged to returning former members who were in good standing at the time of their membership lapse.
2. Officers are not required to pay dues for their individual membership for the year(s) they serve.

3. Applicants whose applications are first read at the October business meeting or later will be have the option of paying pro-rated (1/2) dues and receiving membership for the remainder of the year or of paying a full years dues and receiving the membership for the remainder of the year plus the approaching year.

ARTICLE V

ELIGIBILITY TO VOTE

1. Voting members will be Full Member, Charter and Life Members.
2. No member of the Club in arrears shall be eligible to vote.

ARTICLE VI

VIOLATIONS

Violations of the above rules or any provision of the constitution may result in expulsion of the offender, including termination of membership privileges as provided for in Article 2 of the Constitution of The Southern Indiana Rifle and Pistol Club, Inc.

These revisions to the By-Laws reflect the election of new officers. The officers were elected through a simple majority vote of those members present, who were eligible to vote, at the annual meeting of The Southern Indiana Rifle and Pistol Club, Inc. held on the 25th day of January, 2025.
